

River Thames Scheme Supplementary Consultation

Scheme Overview

The River Thames Scheme (the Scheme) will reduce the risk of flooding to thousands of homes, businesses and vital infrastructure while unlocking the economic, health and environmental benefits of the river between Egham and Teddington and responding to the challenges of climate change and nature recovery.

The Scheme includes a new flood channel in two sections, passing through the boroughs of Runnymede and Spelthorne in Surrey. The Scheme also includes bed lowering of the River Thames downstream of the Desborough Cut and increases in capacity at Sunbury, Molesey and Teddington weirs. The Scheme will create new areas of green and blue open space with recreational facilities and a nature recovery network and provide sustainable travel connections to link communities together.


